



OFFICIAL RULES ALCOSAN's 2020 Summer Sweepstakes

DESCRIPTION:

From August 3, 2020, through September 12, 2020, the Allegheny County Sanitary Authority ("ALCOSAN") will be conducting its "ALCOSAN's 2020 Summer Sweepstakes" (the "Sweepstakes") via its microsite, www.3riversproud.com. The sweepstakes will last 41 days. Each week, one (1) of six (6) prizes will be given away from that week's eligible entries. See official rules for details.

OFFICIAL RULES – NO PURCHASE IS NECESSARY TO ENTER.

SPONSOR: ALCOSAN's 2020 Summer Sweepstakes is sponsored by ALCOSAN, located at 3300 Preble Avenue, Pittsburgh, PA 15233.

ELIGIBILITY: The Summer Sweepstakes are open to all legal residents of the United States, including the District of Columbia, who are age 18 years or older at the time of entry. Void where prohibited by law. Employees of ALCOSAN, 9 Rooftops ("Administrator"), the immediate families of such employees (parents, siblings, children and spouses), members of the same household of such employees, and anyone involved in the production, development or handling of this Sweepstakes are not eligible. All federal, state, and local laws and regulations apply.

HOW TO ENTER: Beginning Monday, August 3, 2020 at 12:00:01 PM EDT, entrants can visit www.3riversproud.com and complete that week's activity to enter the Sweepstakes for that week only. Entrants may enter the Sweepstakes one (1) time each week, for each of the six (6) weeks of the Sweepstakes. Each week, entrants can also "comment" on a pre-specified weekly social post for one extra Sweepstakes entry per week.

Subsequent weeks will all begin on Sundays at 12:00:01 AM EDT and end on the following Saturday at 11:59:59 PM EDT.

Weekly winners will be chosen each Monday by noon (12:00:00 PM EDT) via a random number generator. Notification to the winner will be given via the email address entered during the Sweepstakes entry process and will be posted on the Sweepstakes homepage at www.3riversproud.com, under the "Our Winners" section. The winner of each week's prize will have seven days to respond. If the winner does not respond by 2:00 PM EDT of the seventh

day after notification, a new winner will be chosen using the same random number generator process. Any subsequent winners of that week's Sweepstakes prize will also have seven days in which to respond. All winner decisions are final.

Multiple registrations from the same entrant may result in ineligibility to receive a prize. Administrator's computer is the official time-keeping device for the Sweepstakes. ALCOSAN is not responsible for incomplete or incorrect mailing addresses or invalid entries. All entry information collected becomes the sole property of ALCOSAN and will not be shared or sold.

Online entrants must have a valid email address. If there is a dispute as to the identity of an online or mobile entrant, the prize will be awarded to the authorized account holder of the email address or mobile phone. The "authorized account holder" is defined as the natural person to whom the email address is assigned by an internet service provider, online service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

One (1) \$150.00 LeMont gift card, and one (1) “swag bag” from ALCOSAN. Estimated retail value: \$150.00.

All details of all prizes will be determined by ALCOSAN in its sole discretion. All federal, state, or other tax liabilities (including income taxes) arising from this Sweepstakes will be the sole responsibility of each winner. The winners will each receive a form 1099 at the end of the year for any prizes valued at or above \$600.00. Prizes cannot be transferred by any winner or redeemed for cash, and are valid only for the items detailed above, with no substitution of any prize by any winner. Odds of winning depend upon the number of entries received at the time of each weekly Sweepstakes winner selection.

WINNER NOTIFICATION: Winners will be notified by email only, as well as their first name, last initial and home municipality being posted on the ALCOSAN 3 Rivers Proud Summer Sweepstakes homepage. No other notification will be provided. Winners can expect to receive their prize as soon as possible. Limit of one prize per household. Except where prohibited by law, acceptance of a prize shall constitute and signify the winner’s consent that ALCOSAN may use the winner’s first name, last name initial and municipality of residence in all forms of media, including online on Facebook, Twitter, etc., in perpetuity and without monetary payment or additional consideration.

The arbitrator's award shall be binding and may be entered as a judgment in any court of competent jurisdiction. To the fullest extent permitted by applicable law, no arbitration under this Agreement shall be joined to or consolidated with an arbitration involving any other party subject to this Agreement, whether through class arbitration proceedings or otherwise.

RIGHT-TO-KNOW LAW: As a local agency, ALCOSAN is subject to Pennsylvania's Right-to-Know Law and any records produced in relation to this Sweepstakes may be considered public records available for public access and inspection. Entrants will not be notified in the event ALCOSAN receives a Right-to-Know Law request for records in relation to this Sweepstakes.

DISCLOSURE: If Entrant opts-in to ALCOSAN 3 Rivers Proud program communications, he or she will also be sent occasional updates from ALCOSAN. Information is not shared or sold outside of ALCOSAN.
